PCNA IS AN ACTIVE COMMUNITY HOUSING DEVELOPMENT ORGANIZATION AND IS COMMITTED TO FURTHERING HABITAT'S VISION OF A WORLD IN WHICH EVERYONE HAS A DECENT, AFFORDABLE PLACE TO CALL HOME.
